Tax Installment Payment Plan Service (TIPPS)

Why would you use the TIPPS Plan?

If you find it difficult making a single large payment when your property taxes come due, you can divide the tax bill into monthly installments to make your personal or business budgeting easier.

It is an easy method of making tax payments without the inconvenience of cheque writing, increased cost of postage, There are no line ups or last minute rush to make your payment.

With your permission, your payments can be made automatically through your bank, trust company or credit union.

How does the plan work?

The plan runs from January to December each year.

The first four monthly payments are based on the current year's estimated tax levy (based on last year's tax bill). Your annual tax bill is mailed to you in May. It will identify the current year's levy and show an adjusted monthly payment amount to cover any remaining balance to the end of the year, providing there are no changes in assessment or local improvements.

The Town does not charge for this service, normal banks service charges apply.

What is the Tax Installment Payment

Plan Service?

The TIPPS plan is a tax installment payment plan that enables you to have twelve monthly installments for taxes taken directly from your bank account and credited to your property tax account.

Do I have to reapply every tax year?

You do not have to reapply for this payment plan every year. Your application form is valid until you inform us of your withdrawal from this program.

What if I change bank accounts?

If you change your bank account, please advise the Town's tax department at least <u>two weeks prior</u> to your next payment date. If payments are missed the Town of Rosthern has the option to cancel this agreement.

How do I withdraw from the plan?

You may withdraw from the plan by giving written notice at least <u>two weeks prior</u> to your next payment date.

Note: If you withdraw from the plan or your plan is cancelled, all unpaid taxes become due and payable, and are subject to penalties.

What if I sell my property?

If you sell your property, it is your responsibility to immediately inform Rosthern Town Office to arrange for cancellation of the plan or transfer of the plan at least <u>two weeks prior</u> to your next payment date.

What happens if I miss a payment?

If you miss any payments, the Town of Rosthern has the right to cancel the agreement. A \$20 service charge will be applied to any payments returned by your bank.

How much will my monthly payment be?

Your monthly payment is based on your yearly tax bill (provided there are no arrears on the account). The goal is to have your account at a nil balance by the last payment date (December 31).

Sample Calculations:

Previous Year's Tax Levy \$1,600.15

January through April monthly payments for current year (\$1600.15 / 12 months) \$134.00* *NOTE: Payments are rounded to the next highest dollar.

Current tax bill (Mailed in May) \$1,648.56

Less: Payments <u>\$ 536.00</u> (January through April) Balance Owing <u>\$1,112.55</u> (May through December)

Monthly payments would then be \$140/month (\$1,122.55/8 months = \$139.07*) for the

remainder of the current year.

*NOTE: Payments are rounded to the next highest dollar.

Town of Rosthern Tax Installment

Payment Plan Agreement Conditions

Attach a "void" cheque from the bank account you wish the payment to be withdrawn from.

For a joint account, all depositors must sign if more than one signature is required on cheques issued against the account.

In the event you change bank accounts, you must notify the Town of Rosthern at least **two weeks prior** to your next payment.

If any payments are missed, the Town of Rosthern has the right to cancel the agreement. A \$20 service charge will be applied to any payments returned by your bank.

If you withdraw from the Plan, or your Plan is cancelled, all unpaid taxes become due and payable, and are subject to penalties in accordance with the Discount & Penalty Bylaw.

You may join the Plan at any time on the condition that the Town receives payment of all prior month payments.

This authorization form is valid until you inform us of your withdrawal from this program. You DO NOT need to complete this form every year.
